

“YOUBELI” Terms and Conditions

The Campaign is organized by Merchantrade Asia Sdn Bhd (410591-T) (hereinafter referred interchangeably as “Merchantrade” or “Organizer”). For this campaign, Merchantrade will offer its Merchantrade Money Visa Prepaid Cardholder(s) 5% off when you purchase selected items on Yubeli using a Merchantrade promo code (hereafter “Campaign”). This Campaign subject to following terms and conditions: -

1. Campaign Period

This Campaign shall run from 00:00 hours (MYT) on 20th April 2020 until 23:59 hours (MYT) on the 31th December 2020 (“Campaign Period”).

2. Eligibility

2.1 This Campaign is open to all Merchantrade Money Visa Prepaid Cardholders (hereafter Cardholder(s))

2.2 For the avoidance of doubt, the following persons are NOT eligible to participate in this Campaign:

- a) Cardholder(s) whose accounts have been suspended, cancelled or terminated during Campaign Period.

3. Campaign Mechanics

3.1 To participate in the Campaign, Cardholder(s) must complete the following steps:

Step 1: With exception to Section 3.2.4 below, purchase any items on Yubeli app or website;

Step 2: In payment section, use Merchantrade Money Money Visa Prepaid Card as the mode of payment under debit/credit selection;

Step 3: Key in your card details ie. 16-digit Card number, CVC number and expiry date in the payment section accordingly;

Step 4: Key in the promo code YBMT5;

Step 5: Discount will be deducted from the total amount purchase;

Step 6: Confirm order and proceed to make payment;

Step 7: Once payment is successful promo code is successfully redeemed.

3.2 Other details for reference:

3.2.1 No minimum purchase required.

3.2.2 The maximum amount of discount is capped at RM15.

3.2.3 Promo code only applicable for one successful redemption per Cardholder only.

3.2.4 Promo code is not applicable for purchase of mobile top-up & e-gift card.

3.2.5 The offer is not exchangeable to cash.

3.2.6 If payment fails or is aborted Cardholder(s) will be able to use the promo code again.

3.2.7 Redemption based on while stocks last basis.
