

TERMS AND CONDITIONS OF THE MONEY VISA PREPAID CARD - DOCTOR ON CALL- E-PHARMACY CAMPAIGN

This Merchante Visa Prepaid Card - Doctor On Call- E-Pharmacy Campaign (“Campaign”) is subject to following terms and conditions: -

1. Organizer

The Campaign is organised by Merchante Asia Sdn Bhd (410591-T) (hereinafter referred interchangeably as “Organizer” or “Merchante”). For this Campaign, Merchante has allocated a promo-code (**EPMTRADE**) which allows for RM5 off when spend amount RM50 and above on Doctor On Call- E-Pharmacy. This promo-code is only available for the first 1000 redemptions (“Total Redemptions”).

2. Campaign Period

This Campaign shall run from 00:00 hours (MYT) on 18th February 2021 until 23:59 hours (MYT) on the 30th June 2021 or until the Total Redemptions have been made (“Campaign Period”).

3. Eligibility

The Campaign is open to all Merchante Money Visa Prepaid Cardholders (hereinafter referred as Cardholder(s)). Cardholder(s) whose accounts have been suspended, cancelled or terminated before, during or after Campaign Period are not entitled to participate in this Campaign.

4. Campaign Mechanics

4.1 To participate in the Campaign, eligible Cardholder(s) must complete the following steps:

- Step 1: Access the Doctor On Call- E-Pharmacy on the Merchante Money Visa Prepaid Card Mobile App (“MM App”);
- Step 2: Select items for intended purchase. Items should be at least RM50.
- Step 3: Key in the promo-code **EPMTRADE**;
- Step 4: Discount of RM5 will be deducted from the total purchase amount;
- Step 5: In payment section, select “Credit / Debit Card” as payment method;
- Step 6: Key in your Merchante Money Visa Prepaid Card details i.e. cardholder name, 16-digit Card number, CVC number and expiry date accordingly. For card issuing bank, select “other” and input “Merchante”
- Step 7: Get OTP to confirm order and proceed to make payment;
- Step 8: Once payment is successful promo-code is successfully redeemed.

4.2 Subject to Total Redemptions stated in **Section 1** above the promo-code may only be redeemed by eligible Cardholders once.

5. Other Terms

5.1 In addition to the terms and conditions hereunder, the MVPC Cardholder(s) shall be bound by the terms and conditions of the MVPC Cardholder Agreement.

5.2 Merchante is not and shall not be held responsible for any delay, error or any other problems in the operation of the Campaign caused by or arising from breakdown, technical malfunction of any computer online system, servers or providers, computer equipment, software and/or at any web site or the telecommunications service or a combination thereof,

including injury or damage to you or to any other person's computer or mobile phone related to and/or resulting from participating or downloading materials in or in connection with the Campaign.
